It is brought to notice that, few Teachers are eligible for promotion to more than one post as they have requisite qualifications.

Illustration:

A Secondary Grade Teacher is having B.Sc. (M.P.C) with B.Ed with Maths and Physical Science Methodologies. He / She is eligible for promotion for the posts of School Assistant (Maths) and School Assistant (Phy. Sci.) and also for the post of Low Female Literacy Head Master (LFL HM / PSHM).

In this regard, an undertaking may be obtained from the teacher with regard to his willingness to which post he / she is willing to take promotion after finalization of seniority list and vacancies before web options.

The District Educational Officers concerned and the Regional Joint Director of School Education in the state are requested to take action accordingly in the matter.

It is brought to the notice during review meeting with the District Educational Officers and Regional Joint Director of School Education in the State on 23.1.2023, that the teacher transfer counseling held in the year 2018, certain teachers are working on lien or against vacancies due to non availability of posts and the said teachers have requested to adjust them in the same category of the posts wherever the vacancies available

In view of the above circumstances, in the first instance the Teachers working on lien or against vacancies, may be adjusted in the existing vacancies or alternatively if they are not willing to adjust in the existing vacancies, they may be permitted to participate in general transfers counseling .

Further, if there are no vacancies available in the district in the concerned subject to adjust the teachers who are working against vacancies / lien , those posts shall be displayed for teacher transfer counseling -2023. After completion of the teacher transfer counseling-2023 , they may be adjusted against the available vacancies.

The District Educational Officers in the state are requested to take action accordingly in the matter.
