All the District Educational Officers and the Regional Joint Director of School Education are informed that Government have issued amendments vide reference 4th read above, for the Teachers Transfers (Regulation of Transfers) and Promotions Rules, 2023 rules issued in the G.O.Ms.No.5 School Education (Ser.II) Department) Dt:25-1-2023 as follows:

AMENDMENTS

In the said Rules , the sub rule 5 shall be substituted as under:-

- (i) Head Master/ Head Mistress GR.II (Gazetted) / Teacher who has completed a minimum period of two years service in a category of post in a School as on 01.02.2023 shall be eligible to apply for transfer.**
- (ii) Head Master/ Head Mistress GR.II (Gazetted) / Teacher who were allotted to new local cadre in pursuance to G.O. Ms. No. 317 GA (SPF-1) Department , dt. 6.12.2021 and posted to other districts shall be eligible to apply for transfer.**


In the said Rules, the following shall be added after sub rule I(a) of rule 6, and read as (b)

(b) For service in the present school and rendered service at previous school in respect of who were allotted to new local cadre in pursuance of G.O. Ms. No. 317 GA(SPF-1) Department , dt. 6.12.2021 , based on its location as per the following as on 01.02.2023.

In the said Rule sub rule I(b) of Rule 6 shall be read as sub rule I(c).

A copy of the Government orders vide reference 4th read above is communicated herewith to all the Regional Joint Directors and District Educational Officers in the State for taking necessary action in the matter.

Further, they are requested to follow the orders and proceed with Teachers Transfers (Regulation of Transfers) and Promotions 2023, as per the revised schedule annexed herewith scrupulously.



In exercise of the powers conferred by Section 78 and 99 of Telangana Education Act, 1982 and under Article 309 of the Constitution of India, the Government of Telangana hereby makes the following amendment to the rules regulating the transfers of the categories of Head Masters Gr.II (Gazetted), School Assistants and S.G.T.s and their equivalent categories working in the Government Schools and Z.P.P. and M.P.P Schools in the State of Telangana issued in the G.O.Ms.No.5, School Education (Ser.II) Dept., dtd.25.01.2023:-

AMENDMENTS

In the said Rules; the sub rule (3) of Rule 5 shall be substituted as under:-

- (i) Head Master/Head Mistress Gr.II (Gazetted) / Teacher who has completed a minimum period of two years service in a category of post in a School as on 01.02.2023 shall be eligible to apply for transfer.
- (ii) Head Master/Head Mistress Gr.II (Gazetted)/ Teachers who were allotted to new local cadre in pursuance to G.O.Ms.No.317, GA (SPF-I) Department, dtd.06.12.2021 and posted to other districts shall be eligible to apply for transfer.

In the said Rules, the following shall be added after sub rule I (a) of Rule 6, and read as (b),

- (b) For service in the present school and rendered service at previous school in respect of those who were allotted to new local cadre in pursuance of G.O.Ms.No.317, GA (SPF-I) Dept.,dtd.06.12.2021, based on its locations as per the following as on 01.02.2023.
